# \*\*\*\*\*CONSIDERATIONS & DIPLAY DETAILS:

Do you have your own backdrop or curtains?

This will help you determine if you should request a back wall to help with displaying your product or services. If you need to hang up your product or signs you will need a wall, unless you have a solid background of your own to put up.

## Are you part of a group?

If you need to be directly beside or near another exhibitor, let us know ahead of time to facilitate our mapping task. If so, please indicate clearly the name of the other exhibitor and have them submit their registration forms with yours (if possible).

Trade Show Maps: We do not provide maps ahead of the Trade Show. Sometimes the location of an exhibitor must change due to last-minute requests or in the case of a cancellation. With exhibitors who request and pay for specific locations, such as a corner booth, it could be a corner booth in any part of the arena. Sometimes a vendor must be in a specific location due to the size of the display, certain power requirements, etc. That is why it is very important that you indicate these factors when you fill out your registration form. It is easier to plot the mapping when we have all this information up front, rather than trying to rearrange booths when other vendors are already in place.
