INTERNET: Wireless internet available in the building.

SQUARE FOOTAGE:

Each EXHIBITOR must stay within their allotted purchased space based on square footage. We need to have room for walkways and other booth space.

SET UP/TAKE DOWN:

Each exhibitor is responsible for setup and take down as well as identification signs and backdrops.

**TAKING DOWN OF BOOTH BEFORE 4PM SATURDAY IS PROHIBITED.

<u>LETTERS WILL BE SENT TO VENDORS 1-2 WEEKS BEFORE</u> EVENT TO LIST TIMES FOR SET UP.

NOTE:

CFAR does <u>not</u> supply labour and are not responsible for damage. We <u>do</u> supply overnight security and help out where and when we can.

DISPLAY DETAILS AND INFORMATION:

Do you have your own backdrop or curtains?

This will help you determine if you should request a back wall to help with displaying your product or services. If you need to hang up your product or signs you will need a wall, unless you have a solid background of your own to put up.

Are you part of a group?

If you need to be directly beside or near another exhibitor, let us know ahead of time to facilitate our mapping task. If so, please indicate clearly the name of the other exhibitor and have them submit their registration forms with yours (if possible).

Door prizes:

This is left to each exhibitor. Please let us know if you need any radio coverage of your door prize draws.

<u>Trade Show Maps</u>: We do **not** provide maps ahead of the Trade & Leisure Show. Location of an exhibitor may change due to last-minute space needs on the floor or in the case of a cancellation.

Exhibitors who request and pay for specific locations, such as a corner booth, it could be a corner booth in any part of the arena.

Sometimes a vendor must be in a specific location due to the size of the display, certain power requirements, etc. That is why it is very important that you indicate these factors when you fill out your registration form.

It is easier to plot the mapping when we have all this information up front, rather than trying to rearrange booths when other vendors are already in place.
